Goals and Objectives Implementation

Appendix B:

Goal 1: Minimize future loses from disasters by reducing the risk to people and property.

Objective 1.1- Protection of populations and properties in Pasco County susceptible to economic or physical loss from natural and man-made disasters shall be consistent with the standards established in the Local Mitigation Strategy and other planning documents.

- Pasco County has a local mitigation strategy (LMS) that focuses on community resiliency through identification of all possible threats, natural or manmade that may threaten it. The LMS delineates the intent to actively pursue objectives that mitigate any identified threats and seeks to alleviate the burden on our population.
- Pasco County's Building Construction Services (BCS) adheres by the Florida Building code and ensures structure are built to such standards as to protect from inundation up to 1-foot of free board and wind and gust strengths as a result of tropical storm systems.
- Pasco County's Department of Emergency Management (PDEM) has a dedicated team of mitigation specialist who continuously monitor the county for mitigation opportunities. A focus of the mitigation team is to seek grants for mitigation projects and assist our residents with grant applications for the retrofitting or relocation of their properties.

Objective 1.2 - Encourage higher standards of maintenance to existing drainage systems and retention ponds and monitor cumulative development impacts with a macroscopic view.

- Pasco County observes Stormwater regulations by implementation of the Stormwater Management Requirements (SMR) found at the following link: https://www.pascocountyfl.net/DocumentCenter/View/4184/LDC-Section-9022-Stormwater-Management-Requirements
- Pasco County's SMR provides rules and regulations and enforcement ability to sustain higher standards regulations related to all stormwater conveyances, drainage systems and retention ponds. The SMR is revised and updated as necessary.

Goals and Objectives Implementation

Objective 1.3 - Assure that Pasco County has sufficient shelter space to accommodate evacuees in time of need.

 Pasco County keeps an updated list of our special needs residents. Appropriate shelter space has been made available to accommodate our special needs population. Pasco County also has a Memorandum of Understanding (MoU) with Pasco County schools to convert some of the schools to shelter space as required during times of disaster.

Goal 2: Emphasize pre- and post-disaster planning to decrease vulnerability of existing and new construction to loss.

Objective 2.1- Identify and prioritize vulnerable properties by using topographic and storm surge maps, traffic analysis and evacuation modeling, economic and environmental impact analysis.

 Pasco County's government makes continuous efforts to ensure our population is well informed and as safe as possible. Pasco publishes and updates as necessary an evacuation map depicting evacuation routes, and the severity of various levels of inundation and effects a hurricane would likely cause at its coast, found here: https://www.pascocountyfl.net/3610/Evacuation-Zones

Goal 3: Prevent flood-related repetitive losses from natural disaster through regulation and education.

Objective 3.1- Develop and support public and private projects and programs to retrofit, relocate or acquire properties susceptible to repetitive flooding.

- Pasco County keeps track of all repetitive loss properties within the county. Annual
 information is sent out to repetitive loss properties to inform of their vulnerability,
 mitigation possibilities, and the importance of purchasing flood insurance. Pasco County
 has purchased and continues to consider the purchasing of vulnerable properties to
 convert into green space through FEMA funded programs.
- Pasco County Building Construction Services adheres to the NFIP 50% regulatory rule to ensure all properties meet the minimum FEMA standards.
